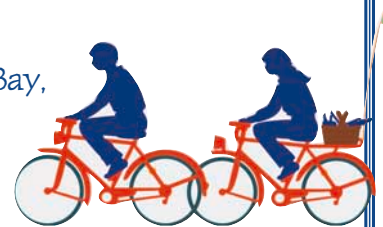

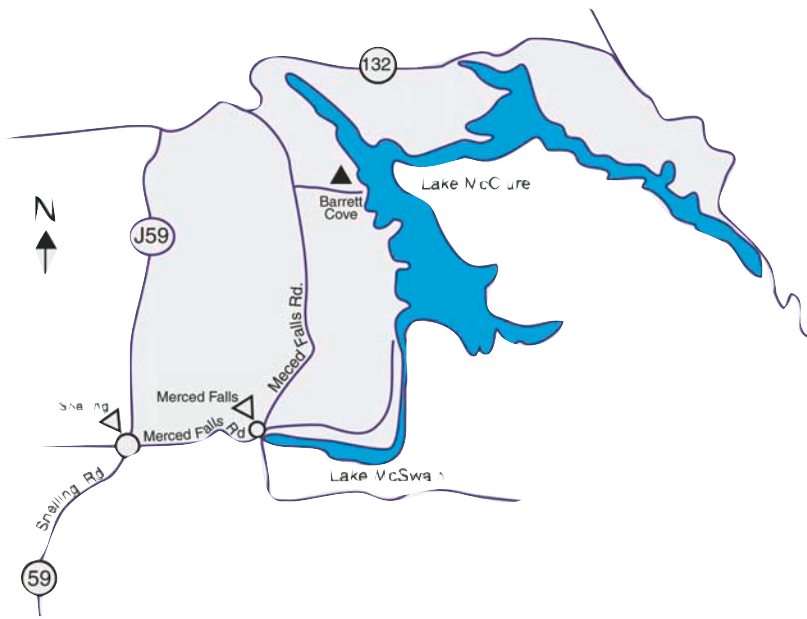

Directions: Follow Rt. 99 north. Exit G Street in Merced. Turn right at the bottom of the off ramp. G St. becomes Snelling Rd. Follow Snelling Rd. until it ends at a "T". Turn right and continue through Snelling.

Follow Merced Falls Rd., to Merced Falls. Just past Merced Falls do NOT turn right to Lake McSwain. Follow Merced Falls Rd. north to the turn off for Barrett Cove. Turn right and follow the road down the hill. Tell the Ranger that you are with CCSC and he will direct you to the proper camping area. Campsites are all in the "L-Loop".

Cancellation Policy: Cancellation fee up to two weeks prior is \$20. Cancellation fee within seven days is 50% trip cost. No cancellation if you are a no show.

Safety— Personal Water Craft

True horror stories abound regarding PWC's (Personal Water Craft) — such as the 18 year old killed on his first day driving a PWC and injuring his 8 year old niece riding on the back. Or the windsurfer killed by a PWC operator who crashed into him at 45 miles per hour.

PWC are fundamentally different from conventional boats in terms of design, operation and use. Their shallow draft design allows PWC to be operated at high speeds in shallow areas close to shore, unlike other motorized boats.

Highly maneuverable and capable of speeds exceeding 65 mph, PWC are marketed as “thrill” vehicles. Common dangerous practices include weaving between vessels, jumping wakes, spinning doughnuts, and radical changes of course, usually unaware of surrounding traffic.

It is important that you know and understand the rules prior to operation any personal water craft which includes Jet skis, Seadoos and Wave Runners.

Age Limits— Under California law you must be at least 16 years old to be in charge of a PWC unless you are at least 14 years old and hold a *Proficiency in Small Craft Safety Certificate* to drive a powered vessel. A person must be at least 16 to operate any vessel powered by a motor more than 15 horsepower. A person 12-15 can operate with adult supervision.

Distance offshore— All boats under 12 feet in length (including PWC), must stay within five nautical miles of the mainland, unless they are within the limits of a port or within one mile of any island.

Safety equipment— PWC get some concessions on safety equipment. They do not have to carry a fire extinguisher or anchor and line. If within a quarter mile of shore, they do not have to carry distress flares. However people onboard a PWC are required to wear a personal flotation device whilst they are operating the craft.

The Rules—

- All riders must wear a properly fitted US Coast Guard approved life jacket.
- Securely attach engine stop lanyard, if provided, to your wrist or life jacket. Keep attached at all times. On models with no lanyard, learn reboarding procedures.
- Look in all directions constantly for other boats, skiers, divers and swimmers, and other personal watercraft. Stay Alert!
- Avoid wake jumping and passing close to any other boats.
- All operators must be of legal age to operate the craft you will be riding.
- Generally, keep to your right and safely avoid other craft. Note that anyone in front of you or crossing your path has the right of way.
- Always operate at a safe speed and be prepared to stop or alter course in emergencies.
- Stay in sight of shore, but avoid operating too close to residential and congested areas.
- Observe all federal, state and local boating laws.
- Do not use alcohol before or during operation.
- Know and understand all operational features of the craft you will be riding.
- Know the waters you will operate in and observe all navigational marks and signs.



Terms—

- Operating a personal watercraft is a serious responsibility. You are operating a boat. Observe all boating regulations and know them before you go!

Freestyle PWC Driving is described as driving your PWC in such a way that the driver of any other vessel would be unable to predict your course and speed in order to avoid a collision with you. In other words, freestyling means altering course and or speed without apparent reason.

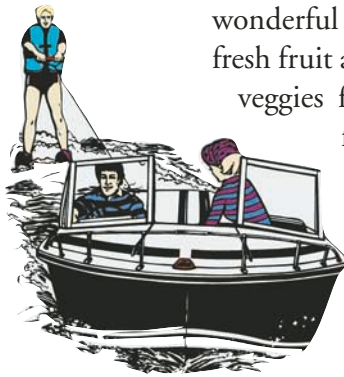
Note to Self-

- #4 September 9, 2001 Playa Del Rey

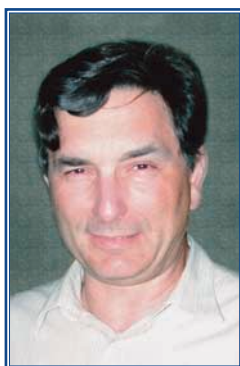

Ski Industry News

Drinking at the Olympics—

Getting a drink at the Olympics next winter just got easier for John Q. Public, thanks to "The Large-Scale Special Events" ordinance, passed June 14, 2001 which will allow beer,

wine and cocktails to be sold and consumed in some city parks. Thanks to this state law, alcohol can be served without a license as long as they don't charge for it.

New Village at Snowmass—

Aspen Skiing Company and Intrawest Corporation announced today they had signed a letter of intent to become partners in order to design and build a base village at Snowmass Ski Area. The village, which will be built on about 12 acres of a 20-acre site, will likely be a pedestrian village blending commercial and residential areas.

Vail Resorts Improvements—

Vail Resorts Inc. (VR) announced plans to invest \$55.8 million in resort improvements during calendar year 2001 for Vail, Breckenridge, Keystone and Beaver Creek in Colorado, as well as the Grand Teton Lodge Company in Jackson, WY.

Year Round Snow—

SnowMagic Entertainment Industries (SMEI) claims it has developed snowmaking equipment that can produce snow in temperatures up to 60° F, without the use of chemicals or additives. This kind of equipment is currently being used to extend the ski season by over three months at traditional ski resorts. In other facilities, it provides snow for indoor skiing and snowboarding venues and special events.

Mt. Bachelor Merger On Hold—

The proposed merger of the Mount Bachelor ski resort with Utah-based Powdr Corp. was shelved indefinitely after both companies were sued by the Pape Group, whose bid for the resort was rejected. The Pape Group, led by former Mount Bachelor Inc. President **Randy Pape**, is seeking about \$15 million in damages, saying part of the merger agreement is unfair to those who hold multiple shares of stock in Mount Bachelor. ▼

Houseboat Safety—

Since CCSC will be once again houseboating on the Delta, I thought this would be a useful safety reminder.



The level of carbon monoxide (CO) found beneath some houseboats is so high, it can kill a person after only a few breaths.

Swim ladder designs on some houseboat models create an air cavity beneath the stern (that's the rear) deck. This space is sometimes a popular place to swim.

Many boats also vent the gasoline generator exhaust into this space which has no outlet, allowing lethal levels of CO to build up in a few minutes.

Sadly, since 1994, nine people have died and more than 100 have needed emergency care. ▼

Health— Preventing Injury

It doesn't necessarily take a mis-timed leap off a cliff on skis to produce a back injury. As we all know, back injuries may be triggered by the most trivial of movements on or off the slopes.

The best way to avoid injury is to think prevention. Flexibility and strength are the key. Recreational skiers should engage in some pre-skiing fitness activity. This could involve swimming, front crawl is best, or brisk walking, 30 to 45 minutes, or stretching exercises. Also low-impact aerobics are great. Whatever exercise you decide to do, you should do it about three to four times a week.

And while you're actually away skiing, it is very important to spend some time doing warm-up and warm-down stretches before and after skiing. This can help get your muscles and joints ready for the day ahead rather than starting cold. This alone can help prevent many problems. ▼

More on PWC Safety from page 8 *PWC Surfing* is described as driving your PWC over or down a breaking wave or swell. The swell may be formed naturally or by passage of a vessel. PWC Surfing is prohibited off most popular beaches. When an area off a popular beach is set aside for PWC Surfing, it will be posted and swimmers will be prohibited from using the area.

PWC Wave Jumping is described as driving your PWC

over a breaking wave or swell with the aim of becoming airborne. The swell may be formed naturally or by passage of a vessel.

PWC Freestyling, Surfing and Wave Jumping are prohibited within 100 feet of another PWC and 150 feet of any other vessel or person in the water. In addition, it may be prohibited in areas where there are speed restrictions or where there is other boating traffic or swimmers. ▼



Chef's Corner

Herb-Encrusted Roast Leg Of Lamb-

Lamb is best served with a full-bodied Merlot. St. Francis, Kenwood Jack London or a Benzinger Merlot would make good choices.



Ingredients-

- 1/4 cup Dijon mustard
- 1/2 cup dry red wine
- 3 tbs minced garlic
- 1/2 cup olive oil
- 1/4 cup minced fresh mint
- 2 tbs finely chopped fresh rosemary
- 2 tbs chopped fresh thyme
- 1 tsp salt
- 1 tsp ground black pepper
- 1 (6 pound) leg of lamb, trimmed of fat

In a bowl, whisk together the mustard, red wine and garlic. Slowly drizzle in the olive oil to form an emulsion, then whisk in the herbs, salt and pepper. Rub the mixture over the lamb, coating the outside completely. Place the lamb in a large plastic bag and cover with any remaining marinade. Seal the bag, refrigerate and let marinate at least 8 and up to 48 hours, turning the bag occasionally to coat evenly.

Preheat the oven to 350 degrees F.

Place the lamb in a large roasting pan and roast until an instant-read thermometer inserted into thickest part of lamb registers 140° F for medium-rare. Remove the lamb from the pan and place on a platter to rest for 15 minutes before carving. Carve the lamb and serve.

Serves 6.

A Bit of Ski History in Los Angeles

by excerpted from Linda Close in *United State Ski News*, December 1982

The history of Southern California skiing is peopled with a cast of characters and events as colorful as any to set foot on a Hollywood sound stage.

Downtown Los Angeles-

There were men like **Vicki (Ludvig) Hasher**, a Bavarian import who found his way to Los Angeles in 1927 and hooked up with a group of Norwegians who called themselves the Viking Ski Club of Los Angeles. In 1931, Hasher won the first official cross-country ski competition held by the newly-formed California Ski Association (later named the Far West Ski Association).

But perhaps the most memorable contribution California's first ski champion made to the sport was his novel way of introducing skiing to new fans. Somehow Hasher convinced the people at the May Company department store to install a ski slide high atop their building in downtown Los Angeles, where snowflakes never fall.

Hasher then taught a bevy of beautiful movie stars, not to mention everyday people, to ski on a surface sprinkled with rice hulls, borax and salt that was 15 feet wide and 84 feet long. The slide had a less-than-breath-taking vertical drop of 16 feet, but it attracted plenty of people to the sport of skiing.

That was back in 1937 when the May Company was advertising a handsome assortment of hickory and maple skis for \$4.95 to \$25. Poles started at \$1.95 and bindings at \$2.95. American and European ski boots sold for the princely sum of \$6.95 to \$18.50.

Hollywood Bowl-

In 1935 thousands of spectators wearing mufflers and sweaters were thrilled by the chills and spills of a ski jumping competition on a canyon slope off the Hollywood Bowl, of all places. Tons of snow was trucked in from the mountains for the occasion. **Olaf Tellefsen** of the Viking Ski Club of Los Angeles won the Class A division with a leap of 120 feet.

Among the competitors was **Johnny Elvrum**, who held the American ski jumping record of 240 feet for a heady five years, until **Alf Engen** came along. Johnny later

joined the Viking Ski Club of Los Angeles and subsequently opened Snow Valley Ski Area in Big Bear.

Los Angeles Coliseum-

A similar competition was held at the Coliseum in 1938, on a man made slide towering 60 feet over one



end of the stadium seats, its runway sloping down onto the football field. Ice machines sprayed 500 tons of ice crunched into snow over the area.

Dodger Stadium-

A ski jumping competition and dual slalom races were held on a man-made scaffold and ski slope at Dodger Stadium as recently as 1962.

The Hills of Los Angeles-

Joe Diener, one of the 12 members of the San Geronio Ski Club who scratched Kratka Ridge out of the mountain in 1950, remembers when going skiing took imagination, ingenuity and just plain hard work. Years ago, if you didn't pack the hill where you went skiing, you didn't ski. You had to earn your ride down by hiking up, a dismal state of affairs that begged for a better solution.

Creative-thinking skiers, therefore devised various methods of conveyance to haul themselves up hill with a minimum of effort. There was a rope tow pulled by a horse, for example. And a ski bus which was a monstrosity.

Yosemite had a boat-like contraption in the late thirties that took about 30 people up the hill at the same time. Of course, you could always drive the old auto up and draw straws to see who would be the lucky one to drive back down and pick up the skiers at the bottom.

In about 1939, Snow Valley had one of the first overhead cable lifts, featuring attachments that looked like a child's swing and transported ten people at a time. ▼
